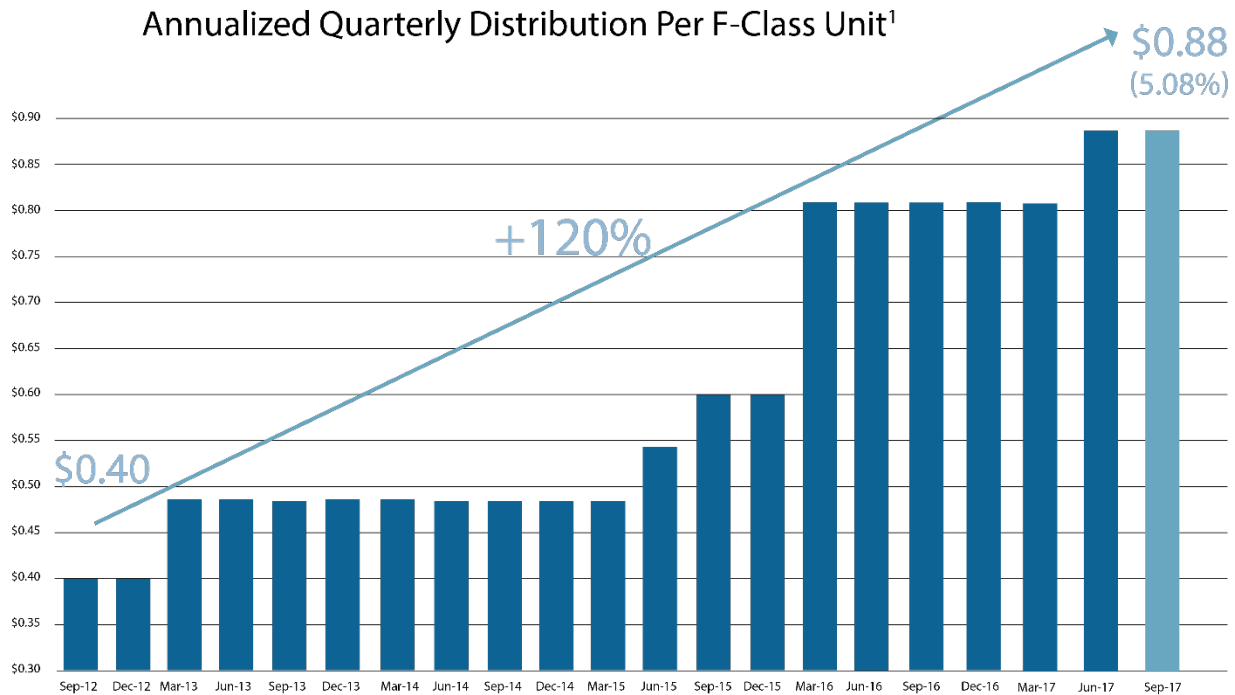
RISE Properties Trust is pleased to announce a \$0.22 CAD\$ per Class F Unit distribution for the third quarter of 2017. This is the 21st consecutive quarterly distribution and will be paid on September 29th, 2017. This quarterly distribution of \$0.22 CAD\$ per Class F Unit produces a 5.08% annualized yield on the Trust’s June 30, 2017 valuation of \$17.3256 per Class F Unit.

Distributions are awarded monthly and paid on a quarterly basis. Unitholders of record on the third business day of each month are awarded 1/3 of the distribution announced for the quarter. A statement explaining the details of your distribution will be mailed to you by SGGG Fund Services.
